A stunning mature Douglas fir woodland with an understory of oak, hazel, ash and cherry set in a quiet larger forested area and served by a good hard surfaced track, 3 miles from Ross-on-Wye.

Description

Perry Wood lies in a delightful wooded valley a short distance From Ross-on-Wye and a few miles from the M50.

The wood is light and open with a level aspect and is surrounded by woodland on all sides. Access from the council road is down a track into the bottom of the valley then along a recently resurfaced track to the edge of the wood.

The majority of the wood is populated by mature Douglas fir, highly valued in the timber industry for its sheer strength and resistance to decay. The amenity value of these grand trees greatly contributes to the wood providing aesthetic appeal throughout the winter months when the leaves are gone.

Between the firs there are young broadleaf trees such as oak, birch and ash. The fringes of the wood support a range of larger native broadleaves including oak and ash, hazel, hawthorn, holly and other shrubs are scattered across the wood.

In addition to such a diverse range of species, ages and habitats, Perry Wood also hosts a flourishing fauna. On most nights fallow deer lie in a thicket at the bottom of the wood. Quiet watching will be amply rewarded. When there we noted a wide variety of woodland birds including nuthatch, woodcock and woodpecker whilst those of a sporting mind may also appreciate the healthy pheasant population.

Perry Wood is an attractive wood large enough to keep the most energetic busy, whether it be wildlife watching, silviculture, recreation, conservation management or just plain enjoyment.

If It Were Mine

I would re-space some of the young trees and clear up some of the wind blown logs. Some maintenance of the track that runs down to a delightful bridge at the bottom corner would enhance this area.

Please remember some management operations require approval and/or a licence.

Residential Planning Permission

You are extremely unlikely to get residential planning permission for this woodland.

Directions & Access

- From Ross-on-Wye: exit roundabout on to A449.
- Follow the road for 3.2 miles.
- The access gate is just after a left hand bend on the right. Sorry we do not provide keys for viewings.
- Park in the layby and continue on foot down the track through points **ABC** (on the plan below) for 400 metres then a further 130 metres to point **D**. This is the start of the wood.

Boundaries

- The north boundary is indicated by white paint on wooden stakes and boundary trees.
- The east boundary is indicated by orange paint boundary trees and wooden posts.
- The south east boundary is the fence.
- The west boundary is indicated by green paint on wooden stakes and boundary trees.

Sporting Rights

The sporting rights are owned and included in the sale. They are not let.

Mineral Rights

The mineral rights are owned and included in the sale except as reserved by statute.

Rights Of Way

- There are no public rights of way in this wood.
- A right of way is granted for this wood from the council road up to the woodland boundary (marked **ABCD** on the plan).
- A right of way is reserved over **DE** for the benefit of the wood beyond.
- A shared maintenance clause covers all the rights of way.

Fencing Liabilities

There are no known fencing liabilities.

Restrictive Covenants By The Transferees
